The Board of County Commissioners of Walton County, Florida, met on this wednesday September 30th, A D 1925, pursuant to adjournment of September 21st, A D 1925, with the following Members present and participating,- R L Jones, W M Infinger, G M Bishop and W I Stinson, Chairman, and the following proceedings were had and done.

Moved by W M Infinger and seconded by G M Bishop, and duly carried by unanimous vote, it was ordered that the Clerk of this Board be and he is hereby authorized and directed to advertise as required by Law that this Board will receive sealed bids until 2 o'clock P M October 20th, A D 1925, for the purpose of purchasing one car of Metal Culberts size 18 to 36 inches in diameter F O B DeFuniak Springs, Fla. Also bids for the purpose of building a bridge across Alaqua Creek at Portland as per plans and specifications to be on file in Clerk's office on or before October 5th, 1925. lso bids for the purpose of purchasing a Tractor to be used in repairing and building county roads, Also bids for the purpose of purchasing one pair of mules about 1100 or 1200 pounds, not more than nine years of age.

Also bids for the purpose of building bridge and fills across Peters creek immediately west of Clear Springs School House, according to plans and specifications to be on file in Clerk's office on or before October 7th, 1925. County to furnish all material. The Board reserves the right to reject any and all bids.
