Moved by R L Jones, seconded by W M Infinger and duly carried, it was ordered that the Tax Assessor be and he is hereby authorized to purchase a new Remington typewriter with long carriage, at a cost of \$190.00 to be charged against the Court House bond Fund

Moved by W M Infinger, seconded by R L Jones and duly carried, it was ordered that J A Crosby, DeFuniak Springs, Fla. be placed upon the Pauper's list at \$5.00 per month until further order of this Board.
