

THURSDAY, July 27th, 1926.

The Board of County Commissioners of Walton County, Florida, met on this July 27th, 1926, with the following members present and participating, E B Mitchell, W M Infinger, G M Bishop and W I Stinson, Chairman and M T Fountain, Clerk, the said meeting was held pursuant to adjournment of July 14th, 1926.

A Road petition having been duly filed with this Board, upon motion made by G M Bishop, seconded by W M Infinger and duly carried by unanimous vote, it was ordered that the road known as the Norwood road, beginning at and intersecting with State Highway No. 1, at the Southwest corner of the NW $\frac{1}{4}$ of Sec. 30 Twp 3 N R 18 W, proceeding northwardly along the western section line of said Section 30 and thence Northwardly on the section line dividing sections 19 and 24 to a point on the western boundard of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 19, Twp 3 N R 18 W, from thence proceeding in a Northeasterly direction and connecting with the SandyCreek or Geneva Road at or near Carpenter's farm, be and the said is hereby declared a public road, providing the property owners will give a right-of-way fifty (50) feet wide, free of cost to Walton County.

Upon motion made by Commissioner G M Bishop, seconded by Commissioner E B Mitchell, and duly carried by unanimous vote of all members present, it was ordered that the following Resolution be adopted,-

Whereas the people of Walton County has voted \$1,000,000.00 for the building of State Highways and a system of County roads, and

Whereas it is the desire of this Board to proceed with the building of the State Highways within this County as soon as possible.

nTherefore Be It Resolved, that the State Road Department of Florida be requested to proceed at once to Walton County and survey the right-of-ways for State Roads No. 33 and 40.

Moved by W M Infinger, seconded by G M Bishop, and duly carried, it was ordered that the following Road Overseers be appointed for the year 1926 or until their successors are appointed and qualified.

James Pitts, Overseer from Portland to New Home Church, road known as Portland and New Home road.

Rube Gibson, Overseer from Portland to County line by Windham head, road known as Portland and Windham head road.

Moved by G M Bishop, seconded by R L Jones, and duly carried, it was ordered that due notice be published in the DeFuniak Herald, that this Board would receive sealed bids until 12 o'clock noon August 17th, 1926, and opened at 2 o'clock P.M. thereafter for the construction of an earth fill across Brown Branch on the Mossy Head--Turner Bridge Road, the fill to be approximately 32 feet wide at the bottom, twenty feet wide at top and six feet high, amount of earth required to construct said fill being estimated at 1,000 to 1,200 cubic yards, earth used in constructing said fill to be taken from the road bed on the hill or hills next nearest the fill, earth to be taken in a manner to leave the road bed in a condition satisfactory to the Board of County Commissioners. Two wheelers owned by the County will be loaned to successful bidder if wanted. Bids will be submitted on a per cubic yard basis. Culverts to be furnished and installed by the County. Successful bidder will be re-

quired to furnish bond or make a deposit of cash for 50% of the contract to guarantee faithful performance. Board reserves right to reject any or all bids.

Upon motion made by Commissioner G M Bishop, seconded by Commissioner E B Mitchell, and duly carried by unanimous vote, the following resolution was ordered adopted,-

Whereas the Board of County Commissioners of Walton County in making up the 1925-1926 budget appropriated the sum of \$2,400.00 to employ a Civil Engineer, and

Whereas, the board does not see fit to employ an Engineer for the current year.~~and~~

Therefore be it resolved that the State Comptroller of the State of Florida be and he is hereby requested to authorize this Board to transfer the sum of \$2400.00 from the item of "Civil Engineer" to "Paid for Free Labor, other than Guards", and to be expended for the last named item.

Moved by R L Jones, seconded by G M Bishop, and duly carried, it was ordered that due notice be published in the DeFuniak Herald that this Board would receive sealed bids until 12 o'clock noon August 17th, 1926, and opened at 2 o'clock P M thereafter for the building of a bridge and fill over and across Gum Creek, near Henry Collinsworth's place, bridge known as the Collinsworth bridge, according to plans and specifications to be on file in the Clerk's office after August 2nd, A D 1926. All bids to be accompanied with a cashier's check for \$50.00 Board to reserve the right to reject any and all bids.

Moved by R L Jones, seconded by G M Bishop and duly carried, resolved that the starting point for State Road No.33 be and same is hereby designated to start at the Okaloosa County line and to be build from the first available funds to be received by or from sale of bonds.

The following Resolution or Certificate was received and filed by the Clerk of this Board on July 2nd, A D 1926,-

CERTIFICATE IN RE 1926 SPECIAL ROAD AND BRIDGE DISTRICT NO.2,
WALTON COUNTY, FLORIDA.

To the Board of County Commissioners, Walton County, Florida. DeFuniak Springs,
Sirs:

Pursuant to Section 7, Chapter 11314, of the Acts of the Legislature of Florida for the year 1925, we have carefully estimated by amount of money necessary to be raised by Special Tax to pay the interest and to crate a sinking fund for the payment of the bonds authorized by said Act, and hereby notify you of our Action and resolution passed thereupon, to-wit:

"WHEREAS Pursuant to Chapter 11314 of the Acts of the Legislature of Florida for the year A. D. 1925, we as the Board of Bond Trustees of Special Road and Bridge District No.2 of Walton County, Florida, are authorized and directed to make a careful estimate of the amount of money necessary to be raised by Special tax to pay the interest and to crate a sinking fund for the payment of the bonds authorized by said Chapter, and to make report thereof to the Board of County Commissioners of said County; and

NOW THEREFORE, BE IT RESOLVED, That the sum of \$1800.00 for interest, and the sum of \$250.00 for the sinking fund is necessary to be raised by special tax for the year A. D. 1926 for said Special Road and Bridge District No.2 of Walton County, Florida, and that there should be levied as said tax 19 mills on the dollar of all the property in said district that said tax for said purposes shall be raised, and that a copy of this Resolution be duly certified to the Board of County Commissioners of said County".
