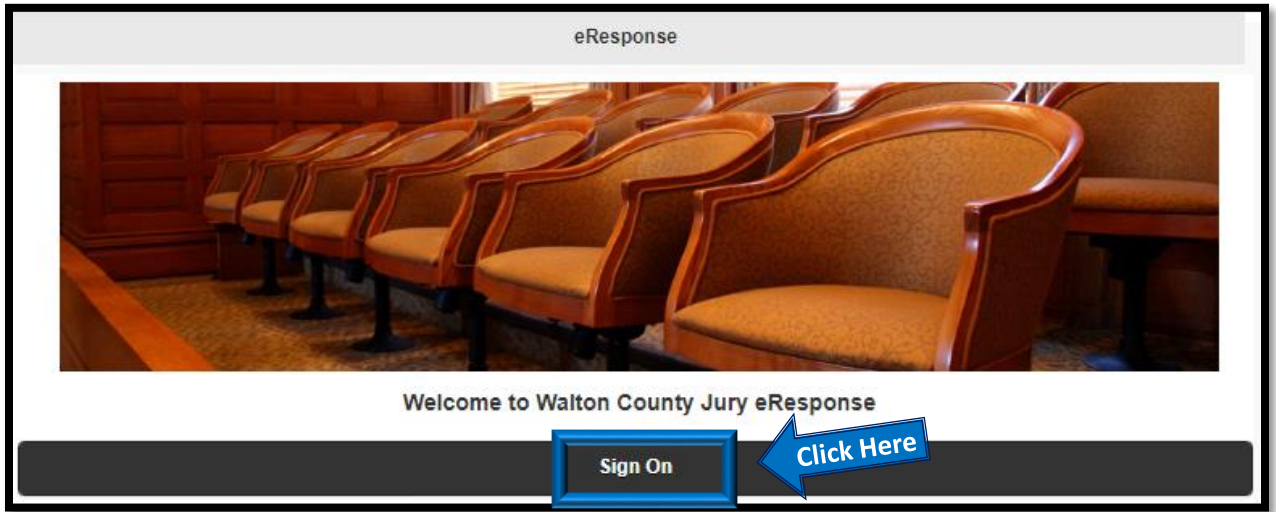




Juror Online Check in Process

Step 1: Visit the [eResponse Website](#) and click Sign On.



Step 2: Sign In

Enter the juror ID (found on your summons), zip code, and date of birth. Click Log In.
